I. Welcome & Introductions

Hisieni Sacasa welcomed the group, introductions were made and the meeting opened at approximately 1:05 pm.

II. Approval of Meeting Minutes

The first item on the agenda was the approval of the Meeting Minutes of May 11, 2018 and the Minutes were approved accordingly.

III. Old Business

a. Dutchess Blueprint

The next item discussed on the agenda was the most recent Blueprint Event that occurred in Dutchess County on May 31st at Dutchess Community College. Hisieni informed the group that there were approximately 25 in attendance from various

organizations including HRH Care, CAPE of Dutchess, Family Services and Dutchess County Department of Behavioral & Community Health.

i. Event summary

Dr. Martine Hackett and Dr. Kenya Beard were the two main speakers for the event. After the poverty simulation, Ally Smith from the Dutchess County Department of Health presented local statistics regarding health disparities in Dutchess County, and Lillian recruited Danny Hairston from SNUGS to speak about their work around gun violence.

Based on feedback from the previous SDOH meeting, a facilitation portion was added to the agenda for the Dutchess Blueprint to encourage action from the participants. The facilitation was not held the day of, but it will be put on the agenda to test at the Rockland event.

ii. Feedback

Overall, the event was rated very well on the participant feedback forms (4.7/5). All individual aspects of the day received a 4 or higher. When asked what people liked most about the event, the most common responses were the simulation, Dr. Beard, and the overall experience. When asked what could be improved, the most common responses were more breaks and better recruitment.

IV. New Business

a. Bootcamp

i. Modified Proposals

Next, Hisieni discussed the Bootcamp. She explained that when we last left off the group thought that the five days proposed for the Bootcamp by Erika Bernabei was too long to complete consecutively. Hisieni has since had a discussion with Erika regarding the group's concerns and Erika is working on a revised Bootcamp Proposal. The tentative proposal suggests splitting up the Boot Camp into two two-day segments.

Rockland Blueprint

Hisieni shared the proposed agenda for the Rockland Blueprint. Small changes to the agenda were made to highlight community assets, and encourage action from the participants during the day. The event will be held at the Rockland County Fire Training Center in Pomona, NY. The Master of Ceremonies has not been confirmed, but we will use both Dr. Martine Hackett and Dr. Kenya Beard as speakers.
